WWPA has revised a previous request to add to section Section 754.00 as follows:

When No.1 and Better Douglas Fir – Larch and Hem-Fir species combinations are gradestamped, it is not permissible to produce concurrently any gradestamped lumber with a higher design value than that item. For example: Select Structural, some MSR and decking grades. Associated with this no prior selection of higher design values products provision, grade stamp shall denote the use of the WWPA rules if the WWPA registered mark is not included in the grade stamping.
